  - a. The singular includes the plural and vice versa;
  - b. References to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
  - c. A reference to a person includes firms, companies, government entities, trusts and partnerships;
  - d. "including" is understood to mean "including without limitation";
  - e. Reference to any statutory provision includes any modification or amendment of it;
  - f. The headings and sub-headings do not form part of this privacy policy.

## Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Kent Home Improvements (Swale) Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

## Data that is given to us by you

#### Data that is collected automatically

This information helps us to make improvements to the Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.

## Our use of Data

- 9. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:
  - a. Internal record keeping;

In each case, in accordance with this privacy policy,

10. We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your rights" below).

## Who we share Data with

11. We may share your Data with the following groups of people for the following reasons:

a. our employees, agents and/or professional advisors - to in return provide information on the service or product requested;

in each case, in accordance with this privacy policy.

## **Keeping Data secure**

- 12. We will use technical and or organisational measures to safeguard your Data, for example:
  - a. Access to your account is controlled by a password and user name that is unique to you.
  - b. We store your Data on secure servers.
- 13. Technical and organisational measures include measures to deal with any suspected data breach. #### **Data retention**

#### Your rights

- 17. You have the following rights in relation to your data:

- 25. You may not transfer any of your rights under this privacy policy to any other person. We may transfer our rights under this privacy policy where we reasonably believe your rights will not be affected.
- 26. If any court or competent authority finds that any provision of this privacy policy (or part of any provision) is invalid, illegal or unenforceable, that provision or partprovision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this privacy policy will not be affected.
- 27. Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.
- 28. This agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
